While the Williams family was enjoying a ball game, their four year old daughter, Roberta, became ill and had to be airlifted to Children's Hospital. Her illness was diagnosed as congenital heart failure with several complications. In an instant, the family's life was turned upside down. Roberta's mom. Sandra, staved in Vancouver for months at a time while her Dad stayed behind working, managing the house and three siblings while travelling back and forth to Vancouver to support his wife and child whenever possible. The costs were astronomical and debilitating to the family placing enormous pressure on everyone.

After meeting many families in the same position from all over the province, Sandra and the Williams family realized that something had to be done to alleviate the financial burden for families in the Comox Valley who were dealing with the medical crisis of a child. It was crucial to them to ensure that the family unit be able to remain intact to give every opportunity for the child to be cared for and heal with their family at their side. They committed to finding a solution for the Comox Valley.

YANA (You Are Not Alone) was founded in 1986, and with a lot of hard work and determination YANA is committed to families of School District 71 with children between the ages of 0-19 receiving treatment that is unavailable locally. This unique charity has funded thousands of trips for medical treatment in Vancouver, Victoria, Toronto and even the U.S. and England.

YANA believes that when a child is ill the whole family requires looking after. Can you imagine your child alone in Vancouver because you couldn't afford the ferry, gas or accommodation to make the trip? Thanks to YANA that burden can be lifted.

YANA's humble beginnings started in the William's home helping one family at a time. Residents of the Comox Valley are eternally grateful to Sandra Williams, her family, and her friends for all of their hard work, determination, and all of the heart that it took to establish this organization. Since its inception, YANA has assisted several hundred families. Comox Valley families will be assisted for years to come because of Sandra's vision.

Sadly, Sandra Williams, the founder of YANA, passed away in 2009. Sandra is an icon in our community and we are humbled by all that she has done for the Comox Valley. She will be fondly remembered.

Our Mission:

YANA provides accommodation and funding to Comox Valley families who need to travel outside the community for medical treatment for a child under 19 or for a pregnant mother.

YANA maintains four fully furnished apartments within walking distance of Children's Hospital and also assists with finding and funding accommodation in alternate treatment destinations. In addition to providing accommodation, YANA provides a daily, weekly or monthly allotment of funds to help with costs of travel, food, parking and unexpected expenses.

In addition, YANA provides St. Joseph's Hospital with funds which are made available to Comox Valley families who have a child or an expecting mother who requires emergency transfer to another hospital.

To access services, YANA ensures a simple, confidential and supportive process which starts with a phone call, an email or a visit to the office.



Financial health



YANA is funded through donations, YANA events and third party fund raising. In order to continue to support families, YANA needs to raise and receive approximately \$250,000 per year. Almost all of YANA's annual funds are raised within the Comox Valley through the generosity of community members who want to reach out to support local families in their time of need.





Looking forward




This past year has been one of change for YANA. Some of these changes include:
